RIDE DETAILS | The ride starts/stops in Warrenton at Cole's Antiques (FM 954 & TX 237) south of Round Top, Texas, just 6.6 miles south of Hwy 290. The ride features routes of 20, 36, 52 and 67 miles and includes multiple rest stops and SAG support. All riders registered before Feb. 6th are guaranteed a t-shirt.
